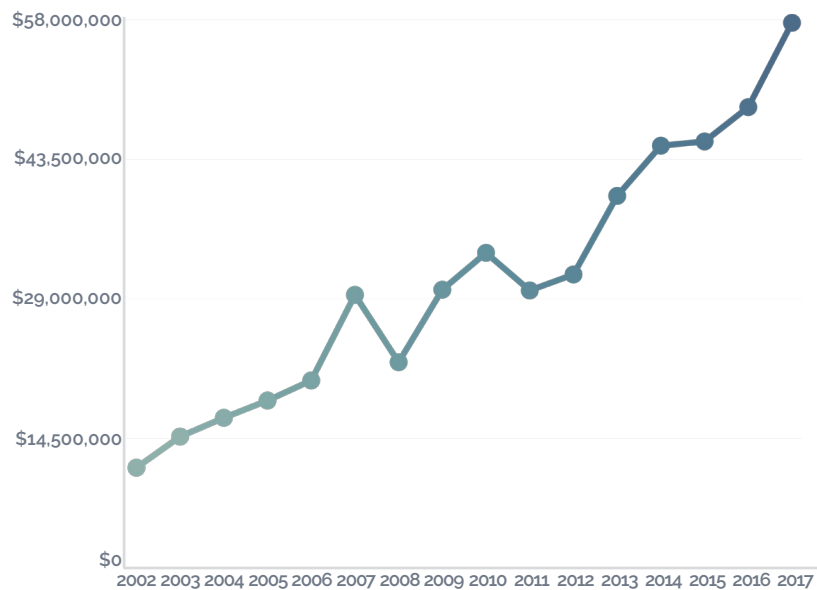


INVESTMENT RETURNS

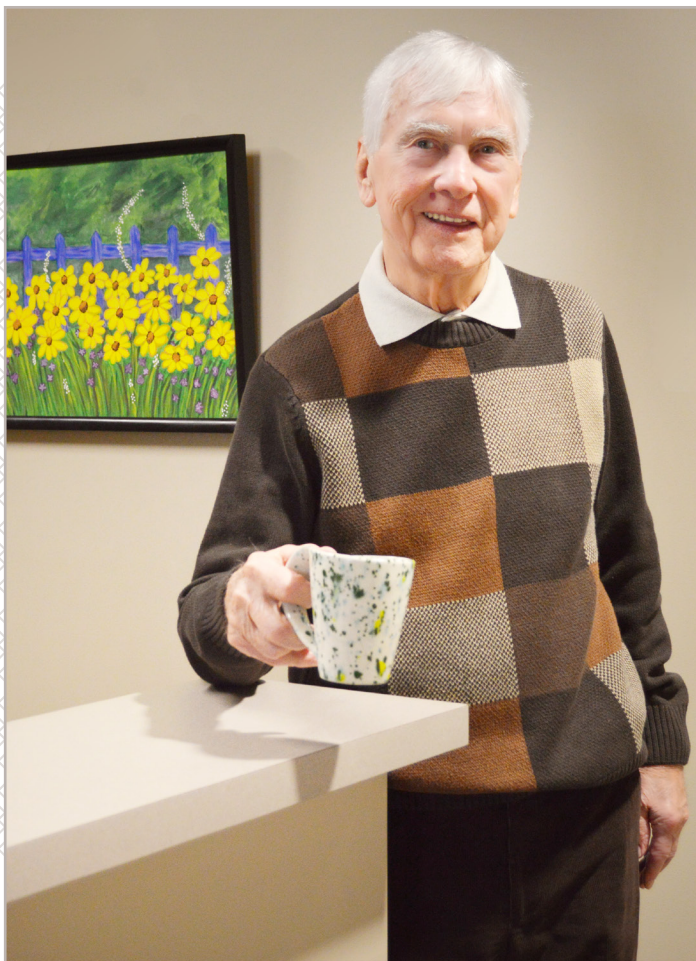

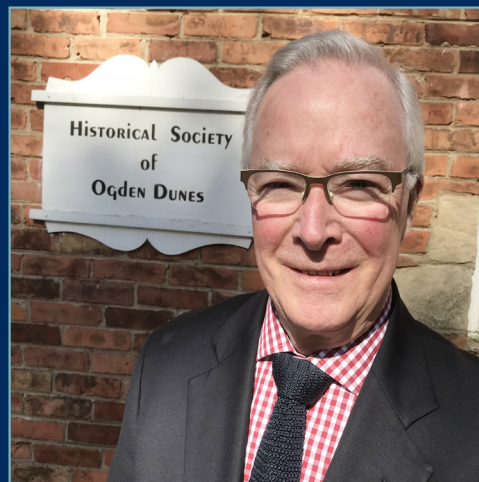
